- City of Charleston for 61 speed reduction Tricia Garrett has written & faxed the City of Charleston requesting a Traffic Calming study to be performed; Tricia will follow up with this request; request has been forwarded to SCDOT (as of Nov 1)
- Fall Community Yard Sale was highly successful, with about 15 households participating
- Bob Jones: street lighting at the end of Rhett Butler will be installed when the Hudson property obtains electricity
- Todd Dunnagan: would like to see last year's budget for comparison to this year's (2008 budget is based on 2007 numbers & has not changed much)
- Tricia Daughtry: would like to investigate installing speed bumps at the beginning of Fair Spring Drive & turning the corner toward Landgrave; Jim Hughes stated this issue has been raised before, but there are concerns about aesthetics, as well as emergency vehicle maneuverability; Todd Dunnagan suggested we investigate speed limit or "Slow Children" signs; Tricia Garrett will work on this, along with the Hwy 61 speed reduction. Additional thoughts for getting the police to do a speed awareness by placing an automated sign or actually stopping those speeding through the neighborhood.
