   Written proposal received from Frank which the HOA Board approved.
   Carolyn will make sure the work gets done.
- Project for next year Need tree arborist to look at trees in main entrance particularly since the heavy rains. Need to do for insurance purposes.
   Carolyn will take lead on this issue and contact an arborist.
  - There is a tree on Blockade Runner on community property that needs pruning. Need to check all community property areas. Need pruning to give place for wind to go.
- Concern was brought up about the amount of Silt in storm drains. Is this
  HOA or city responsibility? Property behind Fair Springs does not drain
  properly. Home owners should not rake leaves into common areas.

  city.

- To do Pump house door framing needs to be fixed.

#### Pool - Linda

- Repair of pool There was a leak but it was dealt with after the pool season was over since the pool needed to be closed to repair it. Now the pool is holding water with no loss. Cost was \$750, much less than expected. The pool company is inspecting the pool twice a week during winter.
- Need to get price for replacing equipment in the pump house.
- Next year we will have to fix cracks.
- Smooth pool season. Lots of volunteers to close pool.
- Is there any way to make the water cooler in summer? Linda asked pool company. There is a way, a heat pump system type of system. They will evaluate pool if our pool is compatible, if so then they will give us an estimate.
- Our drain covers need to be replaced to meet new regulations.

- 11 paid rentals so far this year. All gone well.
- December rentals are all pending, none are final yet. We have coverage for the Dec 26 rental IF it happens. Linda is reminding all potential renters of the deadline to turn in contracts.

- Flower Boxes Irrigation system not sufficient for flower boxes. Frank Dabney
  has been contacted. Need plants that are cold resistant so they don't need to be
  replaced often.
- o All systems are holding up well. Wayne checks on them.
